An Opportunity for Education and **Patient Advocacy**

I wanted to share with everyone about a recent opportunity to provide training and education to our local police force. As you know, Naloxone is the opioid overdose "antidote," that we commonly refer to as Narcan. Many of our police officers and first responders in Georgia already carry Naloxone while on duty. With a little research. I realized that this is not always the case. A neighboring town with a small police force was not equipped to administer Naloxone, nor had the means to purchase this for their officers. As we well know, law enforcement can occasionally pose a challenge when advocating for Medication Assisted Treatment. Inspired by the great work of the Georgia Overdose Prevention Program, I saw a great opportunity.

I first reached out to the Chief of Police. He said that often his officers arrive on the scene of an emergency before EMS arrives. In the past, they have had drug overdoses and were not able to help until EMS arrived. After researching potential options, I found the Kaleo Cares Program, through Kaleo Pharmaceuticals. Kaleo manufactures Evzio, which is an auto-injectable form of Naloxone. It currently retails for approximately \$3,800 without insurance, however they provide Product Donation Grants in certain circumstances. I applied for this grant on behalf of the police department and was granted enough products for each officer free of charge. The paperwork from start to finish took about 6-8 weeks.

I found the officers to be especially grateful, and excited about the possibility of being able to use the medication and potentially save a life. I took the opportunity to give a presentation on Medication Assisted Treatment, before providing the training on administration and safety of Evzio. The officers were incredibly receptive, and I was so excited to see all the questions they had. As we well know, much of the misunderstanding about MAT comes from lack of knowledge.

They asked great questions about driving safety, what services we offer, how patients get take homes, etc. In many cases, officers do not get the chance to see the patients that are thriving in treatment, but only the patients whose choices lead them to break the law. It was important to me that these officers also hear about the patients they don't get the chance to see. I left feeling very positive and hopeful about working together in the future, and they were very grateful for the information.

As a Joint Commission accredited program, this type of advocacy is exactly what we can use towards our Community Education Plan, not to mention the wealth of education I was able to provide our local law enforcement officers. I would encourage any OTPG members who may live in a small town, to consider reaching out to their local police force. Perhaps they are in need of Naloxone themselves, and you can use this opportunity to educate them on your program and MAT in general. I hope this AATOD update finds you all well and enjoying the change in weather as much as I am! If it stavs similar for the next couple of weeks. we should be able to welcome AATOD President Mark Parrino with some familiar temperatures and not shock him with our astoundingly hot summer weather we had in early October!

Speaking of conferences, the next AATOD Conference will be in New York City, March 10-14, 2018. We have a room rate that is only \$10 per night more than when we had the 2009 conference in NYC! Make sure you get your hotel room and register for the conference soon. This year, the Awards Banquet is going to be on Monday night instead of Tuesday, since Monday is the evening that the Broadway shows all take a night off. We may also have an exciting Friend of the Field Award recipient that you'll want to make sure you come and see! There will also be on-site and virtual clinic tours at the 2018 conference, so you can see clinics that are in different parts of New York.

One of the interesting things discussed during the September AATOD Board meeting was how the various states are using the CURES Act money they have received. Many states have funded free Narcan overdose rescue inhalers, while others have actually funded treatment at OTPs for persons without Medicaid or other public support funds and can't afford treatment otherwise. Some states are developing the Vermont Hub and Spoke system to connect people to treatment and address multiple issues the patient may be experiencing. It also seems that some states are spending the funds on prevention efforts. I think it will be interesting to see if any of the initiatives in the various states are more successful than others.

We also explored how many board members know whether clinics are consistently testing for fentanyl. It was determined that the clinics that regularly test are having a significant number of positive results. Georgia doesn't require OTPs to test for this substance, but it may be worth exploring adding it to your drug screen panels. This could get expensive, but I think you should contact the lab that performs your testing and find out the cost. Another idea would be to add it to all your drug screens for one month to determine if your area is experiencing a lot of fentanyl use since this may be a regional issue.

I recently sent out a few documents generated by AATOD, and there was also a direct email blast from AATOD with the documents. You should look at the AATOD Fact Sheet for Criminal Justice and the OTP Siting Policy. These are both located on the AATOD website. In Georgia, the Siting policy is very relevant since we will have our first open enrollment period beginning December 1, 2017 after a year and a half moratorium. There is a mandatory attendance meeting held by the State for anyone interested in submitting a Letter of Intent during the open enrolment period. Details for the meeting can be found on the DCH website, where you will also find the regional map, the proposed regulations for final adoption, and the new initial application packet.

I'm looking forward to seeing many of you at the next OTPG meeting on November 16th and the conference on November 17th!
