ACTOD Update what you need to know

Hello! I hope this AATOD update finds everyone well and enjoying the beautiful Spring weather we've been having across Georgia. As many of you know, this will be my final AATOD update article for the OTPG newsletter. I delayed writing it to the point of irritating Joelyn, since she's in charge of getting this newsletter out on time. After all, this final article is another reminder that my position of representing Georgia on AATOD is ending soon. I've truly enjoyed representing the providers and have learned and grown so much through my over fifteen years of having a seat on the AATOD Board. I hope that the next person understands the responsibility of this position and represents our state well! I'm always available to help with the transition and field questions from anyone that reaches out. I am pleased to report that Mark Parrino has agreed to allow me to remain on the AATOD Legislative Committee as an ad hoc member. This means you guys have not escaped email updates from me guite yet! Due to his decision, I will still be attending the Hill Day portions of the AATOD meetings, which means I will continue to have appointments with our congressional representatives and may at some point in the future reach out to you to have an appointment with me or contact your congressperson to address an issue impacting our field.

On to the actual AATOD update! On March 29th, Nicole Habbe and I headed to Washington, D.C. to complete two in person meetings with legislative staff. We also completed three virtual meetings on various days surrounding the March 29th date. Many of you may remember that Section 4 of the OTAA legislation last year did not make it into the final bill that was passed by the House and Senate. Unfortunately, Senator Markey and Representative Norcross have created an entire bill that addresses this section and reintroduced it as H.R. 1359 and S. 644, the Modernizing Opioid Treatment Access Act (MOTAA). This new bill would allow addiction certified and OTP physicians to write prescriptions for methadone to be filled in community pharmacies. As with the bill last year, proponents of this strategy assert that this will increase access to care that is badly needed. AATOD's position is that there may be unintended consequences to public health and the overdose rate for methadone if MOTAA is passed. AATOD also states that the results of removing the X waiver as a means to increasing access have also not been seen yet. These messages were conveyed by Nicole and myself during our meetings. We also shared the significant differences between buprenorphine and methadone, as well as the differences between treatment in an OTP versus a doctor's office setting. We both feel that our message was heard during many of these meetings, with staff members asking pertinent questions. Meetings were held with Senators Warnock and Ossoff's offices, as well as Representatives Buddy Carter, Lucy McBath, and Andrew Clyde.

As usual during the board meeting, many topics were discussed. There seems to be great expansion of the mobile van option for treatment. This is a real way that more rural communities will gain access to safe and effective treatment. One of the mobile van manufacturing companies report they have thirty vans in the works that will be deployed in various locations throughout the US. While it seems like Georgia may be covered up with clinics, there are still some very real gaps in access in the most rural parts of our state. I hope that members of OTPG advocate to the State to allow mobile vans. An update on the New York legislation passed last year was provided. As many of you may know, NY passed a law that requires all jails and prisons to offer MAT with all three medications to those incarcerated. New York has begun this roll-out by targeting those that are already in care receiving medications and ensuring they continue on those medications if incarcerated. They have identified at least five jails or prisons within the state that have partnerships with OTPs to provide medication. The next stage for them is to begin inducting persons with OUD that become incarcerated and are not currently in treatment. While Georgia may not have this law, we do have a new and very valuable ally in the State now. Our verv own Erica Acebo-Johnston is now the Statewide Medication Assisted Treatment Coordinator for Accountability courts in Georgia. She has begun working to make connections between the court system and OTPs in areas where those courts are receiving State funds. She is also working to provide education and connections within systems that don't receive funds. I hope that many of you will be able to participate in meetings with her and make real progress towards our field's integration into the Criminal Justice world!

And finally! AATOD will be having an in-person conference in Las Vegas, Nevada May 18th through 22nd, 2024 at the Planet Hollywood hotel. The room rate is a reasonable \$209/night and this includes the \$45.95 resort fee. I'm so excited that by obtaining a new position within our filed, albeit a different area, I'll be able have the opportunity to learn at the conference and see everyone at this fabulous event! The website link and registration information will be disseminated at a later date by my predecessor.



And with that, as I get teary eyed, I conclude my final AATOD Update. It's been quite a pleasure to represent all of you over the years and I hope we can continue to work together towards

Fentanyl Awareness

National Fentanyl Awareness Day (May 10, 2022) It was aimed to amplify nationwide efforts to increase awareness and decrease demand for fentanyl, which is a highly addictive synthetic opioid that continues to drive the overdose epidemic.

According to the CDC, 107,375 people in the United States died of drug overdoses and drug poisonings in the 12-month period ending in January 2022. A staggering 67 percent of those deaths involved synthetic opioids like fentanyl. Some of these deaths were attributed to fentanyl mixed with other illicit drugs like cocaine, methamphetamine, and heroin, with many users unaware they were actually taking fentanyl. Only two milligrams of fentanyl is considered a potentially lethal dose; it's particularly dangerous for someone who does not have a tolerance to opioids.
