Greetings Providers, A Patient's Testimony!



Recovery is not a straight line. For someone like me, who has struggled with opioid addiction, every day can feel like a balancing act between stability and relapse. Methadone treatment is what keeps me steady, and without it, I know I would be at high risk of falling back into old patterns. The grant I receive to help cover the costs of my methadone treatment has been one of the most important supports in my recovery. It is not just financial assistance—it is the reason I can keep building a life away from opioids. When I first began this journey, one of my

biggest fears was not only whether the treatment would work, but whether I could afford to stay on it long enough to see the benefits. Addiction takes everything—money, energy, relationships, and time. I entered treatment with very little left. Methadone gave me a foundation, but the grant made it possible to actually stay with the program. Without that safety net, the stress of figuring out how to pay for treatment could have pushed me right back into the cycle I was trying so hard to escape.

The truth is, methadone is more than just a medication to me. It represents stability. It helps balance my body so that I'm not constantly sick or craving drugs. Before methadone, my days revolved around trying to get well. I would wake up every morning already anxious and desperate, wondering how I would get through the day without being in withdrawal. Every decision I made was tied to finding the next high. That life is exhausting and dangerous. With methadone, I don't wake up sick anymore. I don't spend every minute of the day chasing opioids. I can think about real goals and responsibilities.

The grant plays a huge role in that stability. It takes away the financial barrier that could stand between me and my treatment. Instead of panicking about whether I can afford my next dose, I can focus on making progress. That peace of mind is powerful. It gives me the ability to go to my clinic appointments consistently. stay accountable to my program, and avoid slipping back into old habits. It is one less burden on my shoulders, and in recovery, every bit of relief matters. Having access to methadone through this grant has also had a positive effect on my relationships. Addiction strained or destroyed many of the connections in my life, but now I have a chance to rebuild. I can be present with my family in a way I couldn't before. I can show up for the people who matter to me instead of letting my addiction control me. Every time I walk into the clinic and take my dose, I'm choosing to be a better version of myself. That choice is possible because the grant keeps treatment within reach. I also think about my future differently now. Addiction made me feel like I didn't have one-that I was stuck in a cycle I couldn't break. But with methadone and the support of the grant, I see opportunities ahead of me. I want to work, to set goals, to live a life where I'm not defined by my past mistakes. Every day I stay in treatment is a step closer to that future. The grant gives me the breathing room to focus on building that life instead of just surviving.

Of course, recovery is not easy. There are still days when I struggle, when old thoughts or temptations creep in. But methadone helps me manage those moments, and the grant makes sure that help is always available. I know that without these supports, it would be so much harder to stay clean. It only takes one slip, one moment of weakness, to undo so much progress. That's why consistent access to treatment is so important, and why I am so grateful for the grant that makes it possible.

To me, this grant is more than financial help—it is hope.

It is an investment in my recovery, my health, and my future. It allows me to continue receiving the treatment that keeps me from falling back into a life of addiction. And most of all, it gives me the chance to keep moving forward, one day at a time.
